The reporting person has deferred the payout of his Performance Share Award under The Toro Company Deferred Compensation Plan for Officers (the "Deferred Plan") and, accordingly, the reporting person's Performance Share Award is paid in performance share units under the Deferred Plan.
- Includes the following shares of common stock acquired by the reporting person since the date of his last report: 60,359 shares acquired under the dividend reinvestment feature of The Toro Company Investment, Savings & ESOP (IS&ESOP); and 79.35 shares acquired through issuer annual investment fund contributions to and revenue credit allocations in the IS&ESOP.
- The option vests in three equal annual installments commencing on the first anniversary of the date of grant.
