The reporting person has deferred the payout of her Performance Share Award under The Toro Company Deferred Compensation Plan for Officers (the "Deferred Plan") and, accordingly, the reporting person's Performance Share Award is paid in performance share units under the Deferred Plan.
- Includes 116.723 performance share units acquired by the reporting person under the dividend reinvestment feature of the Deferred Plan since the date of her last report.
- Includes the following shares of common stock acquired by the reporting person since the date of her last report: 1.477 shares acquired under the dividend reinvestment feature of The Toro Company Investment, Savings & ESOP (IS&ESOP); and 78.041 shares acquired through issuer annual investment fund contributions to and revenue credit allocations in the IS&ESOP.
